REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli reported that, for the fifth year in a row, the City is being recognized by the International City/County Management Association (ICMA) for its data-driven management and reporting efforts with a Certificate of Excellence, noting Tacoma is one of just 25 jurisdictions receiving this highest level award. She then provided information on Results253, an online portal that provides community members with dashboard access to data-driven stories about the organization's progress towards its long-term goals.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member Mello, Chair of the Infrastructure, Planning, and Sustainability Committee, reported on June 28, 2017, the Committee held interviews and recommended individuals for appointment or reappointment to the Planning Commission, the Board of Building Appeals, and the Sustainable Tacoma Commission. He stated the July 12, 2017 meeting was cancelled. He then reported on July 26, 2017, Planning and Development Services provided an update on the residential infill pilot project, Public Works and the Transportation Commission reported on the annual report and work plan, and the Office of Environmental Policy and Sustainability provided an overview of the next phase of the Healthy Homes Healthy Neighborhoods project. He concluded by stating the next meeting is August 9, 2017, and will include an update on the implementation of Safe Routes to Schools.

Council Member Ibsen provided information on cooling center locations for the anticipated high temperatures this week, then announced there will be a community cleanup on Saturday, August 5, 2017, at 10:00 a.m., at the Pierce Transit Park and Ride Lot, 7201 6th Avenue, in partnership with the West End Neighborhood Council.

Deputy Mayor Thoms announced there will be a community cleanup on Saturday, August 12, 2017, at 10:00 a.m., at Jason Lee Middle School, 602 North Sprague Avenue, in partnership with the North Slope Historic District. He stated on Sunday he represented the City at a memorial service for Dawn Lucien, noting her many years of service to the community. He then stated yesterday he attended the dedication of George Weyerhaeuser Jr. Park on the Foss Waterway.

Deputy Mayor Thoms then stated tonight is the 34th Annual National Night Out, where communities and neighborhoods in Tacoma and Pierce County gather to heighten crime and drug prevention awareness and to aid local anti-crime efforts while strengthening neighborhoods and police-community partnerships.
