The appeal began at 5:38 p.m.

Mayor Strickland stated it is the Council's intention that this hearing be fair in form and substance, as well as in appearance, and asked any Council Members who have a personal interest in this matter, have made statements that might be interpreted to suggest they have prejudged this matter, or have had any ex parte communications with the parties regarding this case, to disclose that at this time.

Council Member Campbell disclosed a remote interest relative to the YWCA, stating that he serves on the Public Policy Committee, which has no financial authority or discussions.

Council Member McCarthy disclosed that his spouse serves on the YWCA Board and stated he is recusing himself from the appeal.

Mayor Strickland called on Margaret Y. Archer, representing appellants William and Ann Riley.

Mayor Strickland then called on Heather L. Burgess, representing appellant YWCA Pierce County.

Mayor Strickland then called on Deputy City Attorney Steve Victor, representing the City of Tacoma.

Mayor Strickland opened the appeal for questions from the City Council.

MOTION: Deputy Mayor Thoms moved to convene to Closed Session in Room 148 pursuant to RCW 42.30.140(2) to deliberate the appeal, not exceed 15 minutes.

#### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

#### **Economic Development Committee**

Council Member Campbell, Chair of the Economic Development Committee, stated at the meeting on July 25, 2017, staff from the Tacoma Venues and Events Department, Travel Tacoma, Metro Parks, and Tacoma South Sound Sports Commission shared how the City of Tacoma and their local partners apply recreation and tourism to promote economic development, and the Committee was briefed on the economic impact the arts and cultural sector has on the City and Pierce County. He then reported on August 8, 2017, the Committee held interviews for the City Events and Recognitions Committee and hosted a delegation from Tacoma's 15th Sister City, Brovary, Ukraine, where the Mayor of Brovary and his delegation shared the commonalities between the two cities and invited members of the Committee to visit later in the year. Finally, he reported on August 22, 2017, staff briefed the Committee on the various transit-oriented development under way around the City, including the new Amtrak Station in the Dome District, Sound Transit LINK Expansion, and new housing development, Trax, which will be the first project in Tacoma that will provide an ORCA transportation pass to each resident.
