### **COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL**

Infrastructure, Planning, and Sustainability Committee

Council Member Mello, Chair of the Infrastructure, Planning, and Sustainability Committee (IPS), reported the March 14, 2018 meeting was cancelled due to the National League of Cities Conference. On March 28, 2018, the Committee received an update on commercial carry service charge from Environmental Services staff to utilize the City solid waste services for campus-style developments, an update on the Six-Year Transportation Improvement Program with a list of prioritized projects, and a briefing on Nature's Scorecard program by Puget Soudkeeper and Washington State Environmental Council, which scores local cities on their commitment for green, low-impact development. He then stated Tacoma was one of the cities awarded as a Green Star Leader for improving the health of local waterways, streams, lakes, and Puget Sound. He concluded by stating the next meeting on April 11, 2018, will include the 2017 IPS annual report and an update on the proposed changes to the temporary shelters building code.
