Government Performance and Finance Committee (continued from December 4, 2018)

Deputy Mayor Ibsen, Chair of the Government Performance and Finance Committee, reported at the November 20, 2018 meeting, the Committee received presentations on minimum wage for workers with disabilities and the responsive bidding process. He stated that the December 4, 2018 meeting was cancelled; and at the special joint meeting with the Audit Advisory Board on December 11, 2018, the Committee received presentations on the 2018 audit entrance conference, environmentally and socially responsible investing, a process for filling Council vacancies, and proposed changes to Citywide collections process; and interviewed applicants for the Board of Ethics. Infrastructure, Planning, and Sustainability Committee

Council Member Mello, Chair of the Infrastructure, Planning, and Sustainability Committee, stated that the November 28, 2018 meeting was cancelled; and the Committee held a special meeting on December 6, 2018, where the Committee received a presentation on electric vehicles, and interviewed applicants for the Landmarks Preservation Commission. He concluded by stating the next meeting will be a special meeting tomorrow, December 12, 2018, at 4:00 p.m., and will include presentations on commingled recycling, accessory dwelling units, and urban agriculture assessment report findings.
