# **Call to Order**

# Joint City Council/Public Utility Board Briefing Items

1. <u>18-0699</u> Tacoma Public Utilities Low Income Program Update

At approximately 12:06 p.m., Linda McCrea, Interim Director, Tacoma Public Utilities (TPU), made opening remarks and introduced Steve Hatcher, Customer Services Manager, TPU. Mr. Hatcher provided an overview of the Utility Assistance Program strategies, background information, and introduced Francine Artis, Customer Services Assistant Manager, TPU. Ms. Artis provided an overview and information related to the program, including history; purpose and issues; goals; a holistic approach to assistance; alleviating to seek customer solutions; and educating the public on two assistance programs. She further explained the two assistance programs, including a comparison between the two programs, the criteria, benefits, and how they work. She stated the City is in partnership with Tacoma Goodwill to offer "Key to Change", a Financial Education Credit Course, and noted all of the programs available to the community are aligned with the City's Tacoma 2025 strategic plan. Ms. Artis then continued reviewing resources and partnerships, demographics of both programs, 2018 short-term outreach strategy, and the proposed budget for the Bill Credit Assistance Plan. She concluded on multilingual marketing and communication strategies, and next steps.

Discussion ensued regarding federal poverty level guidelines for the Utility Assistance Programs, age requirement for the Discount Rate Program, eligibility and best option examples for both programs, bill reduction and reimbursement when issues or mistakes arise, marketing and outreach strategies, and providing brochures through local transportation agencies. Discussion continued on where the funding is originating from, what happens to unutilized funds, updating the software of TPU kiosks located in Safeway stores to accommodate the two programs, kiosk locations, ways to notify the public when they are eligible for either program, status on the success rate, and budget impact.

#### 2. <u>18-0700</u> Tacoma Public Utilities Proposed Rates and Budget Communication Plan

At approximately 1:00 p.m., Ms. McCrea, introduced the next topic, proposed rates and budget communication plan, and introduced Rebekah Anderson, Market Communications Manager, and Clark Mather, Government Relations Officer, TPU. Ms. Anderson provided background information on the collaborative process. Mr. Mather then reviewed the overview; rates outreach in 2017; and the proposed 2018 budget and rates outreach strategy, noting the collaborative work with General Government departments and external partnerships. Ms. Anderson provided information on customer communications approach and strategies, including year-round conversation; and early, multi-channel notifications for rate adjustments, noting resources can be available at public meetings and community groups. She then reviewed customer communications tactics, messages, and proposed channels; and the timeline.

Discussion ensued regarding public outreach.

The joint study session held a short recess at 1:24 p.m. and reconvened at 1:35 p.m.

Council Member Mello discussed an item on tonight's agenda, Resolution No. 40045 relating to traffic enforcement, including the camera locations, the number of cameras, and the reasoning behind the change in vendor.

City Manager Pauli stated TPU customers are currently being targeted by scammers, consequently the Media and Communications and TPU staff are working diligently to notify the public and combat the scam.
