JOINT MEETING WITH THE PUBLIC UTILITY BOARD

Call to Order

Mayor Woodards called the joint study session to order at 12:11 p.m.

Joint City Council/Public Utility Board Briefing Item

1. <u>18-0990</u> Presentation on the Click! Broadband Public Option Informational Study

At approximately 12:12 p.m., Bill Fosbre, City Attorney, made opening remarks and introduced Joanne Hovis, President, CTC Technology & Energy (CTC). Ms. Hovis provided information relative to Click! analysis of public and public-private collaboration models, including the agenda and background, noting CTC-developed options.

Board Member Larkin arrived here, at 12:16 p.m.

Ms. Hovis continued reviewing the City's 12 policy goals and the needed investment. She presented the public model, including its elements; the goal of the scenarios, reviewing Scenario 1: Tacoma Public Utility Estimate,

Scenario 2: Mid-range Estimate, and Scenario 3: High-end Estimate; scenario summary; and the summary of findings. Ms. Hovis then provided information on the public-private collaboration model, including its elements and the summary of findings. She concluded by reviewing next steps, including negotiation and a meeting date with the Public Utility Board.

Discussion ensued regarding the difference between the public model and the current system; how the tax fee will be generated, its source of revenue, and the authority; public model versus public-private model; the concern for fiscal impact on taxpayers; and the importance of the City's 12 policy goals, contract language, and robust public outreach. Discussion continued on risks associated with the models; the concern for not offering cable television; internet as a utility; the importance of a good, long-term contract and enforcement mechanisms; anticipated challenges; and the importance of providing options to the public and gathering public input.

The joint meeting adjourned and the City Council recessed at 1:18 p.m.

The regular study session reconvened at 1:26 p.m.
