### Call to Order

Mayor Woodards called the study session to order at 12:17 p.m.

### Briefing Items

1. [18-1313](#) Budget Presentation - Tacoma Venues and Events Proposed Budget and City Council Requests for the Proposed Biennial Budget

At approximately 12:18 p.m., Kim Bedier, Director, Tacoma Venues and Events (TVE), provided introductory remarks and presented the TVE budget, including an overview of programs, major accomplishments, outstanding challenges, funding, expenses, department goals and major initiatives, recent organizational changes to the department, and partnerships.

Discussion ensued regarding Proposition 1 "Tacoma Creates"; impact of upcoming Key Arena renovations on Tacoma event schedules; Tacoma Dome renovations, roof cleaning, and color options; options to provide space for the Tacoma Stars indoor soccer team; opportunities to partner with the Puyallup Tribe of Indians; and a recent article in Venues magazine.

City Manager Elizabeth Pauli presented recommended adjustments to the 2019-2020 Biennial Budget and described input received from the community, Council Members, and staff; proposed adjustments to the Economic Development, Human and Community Services, Streets Infrastructure, and Library budgets; recommended reductions to other programs to cover costs of the adjustments; and staff work on proposed adjustments based on Council requests.

Discussion ensued regarding Council requests and projects; Police Department staffing, equipment, and fleet costs; a request for regular reports on hiring and staffing needs; speed humps; prioritization of Council budget priorities and commitments; and partnerships for community centers. Mayor Woodards concluded with a review of next steps, including a public hearing and first reading of the budget ordinance.

## **Other Items of Interest**

Mayor Woodards stated she will provide Council Members with an update on the proposed 2019 Bluebird Leadership Institute project next week.
