 Human Rights Commission Annual Report

 [Rebecca Stith, Chair, Human Rights Commission; Brad Bates, Commissioner, Human Rights Commission]

At approximately 4:36 p.m., Rebecca Stith, Chair, Human Rights Commission (HRC), made opening remarks.

Council Member Camarata arrived here, at 4:36 p.m.

Ms. Stith introduced Brad Bates, Commissioner, HRC, provided a background on HRC member positions and described the Commission's goals. She then presented the HRC annual report, including stating the commission is in a citizen-advisory role, the Commission's purpose, current protected categories in Section 1.29.010 of the Tacoma Municipal Code (TMC), and principal duties and powers. Ms. Stith provided a snapshot of significant events in HRC's 50-year history, HRC accomplishments from January 2017 to June 2018, and the current work of the HRC standing committees. Mr. Bates presented the current work of the HRC task forces, details about the work of the task force that is focused on charity care access for non-English speakers, and provided an interim report. He concluded by reviewing concerns and possible causes of high turnover and absenteeism on the Commission, and provided recommendations.

Discussion ensued regarding how often the Commission reviews the anti-discrimination statement in TMC Section 1.29.010 and if the statement provided is the same as the City's, the geographic representation and demographics of the Commission, formal and informal channels of communication between Commissions and Council Members, and implementation of educational training on race and equity. Discussion concluded on the concerns and possible causes of high turnover and absenteeism.
