2.	<u>18-0259</u>	State Auditor's Office 2016 Exit Conference - Accountability Audit and 2017 Entrance Conference [Susan Calderon, Assistant Finance Director/Controller, Finance Department, Linda Mastin, Assistant Audit Manager, State Auditor's Office]
		At approximately 10:03 a.m., Susan Calderon, Assistant Director, Finance, made opening remarks and introduced Joanne Klein, Audit Manager, and Linda Mastin, Assistant Audit Manager, Washington State Auditor's Office. Ms. Klein and Ms. Mastin presented an overview of the 2016 accountability audit result, including internal controls; state laws and regulations; audit highlights; departments audited; legal compliance areas audited; departmental recommendations; and other related reports. Ms. Klein provided an overview of the 2017 financial, federal, and accountability audit scope, including phases of the audit timeline; helpful tips; expected communications; new accounting standards; and contact information for all parties involved.
		Discussion ensued throughout regarding the Tacoma Public Utilities contract amendment, whether departmental recommendations were formalized in a letter or not, uses of the Tacoma Police Department confidential funds and seized funds, if the confidential funds are being reviewed and monitored, and what monies are being allocated to Moss Adams.
3.	<u>18-0295</u>	Year-end 2017 24/7 Performance and Open Data Review [Jared Eyer, Senior Management Budget Analyst, Office of Management and Budget]
		At approximately 10:22 a.m., Katie Johnston, Senior Financial Manager, Office of Management and Budget, gave opening remarks and introduced Jared Eyer, Management Analyst, Office of Management and Budget. Ms. Johnston provided background information regarding the Open Data Initiative from the years 2014-2017, the primary goals, and how the goals are being integrated. Mr. Eyer presented the performance goals and 2017 results. Ms. Johnston reviewed the performance management over time, including Phase 1 from 2004-2014, Phase II from 2013-2016, and Phase III from 2017. Mr. Eyer concluded with examples of the improved dashboards, next steps including Results 253 and budget development, new goal tiles, and data sets and pages.
