At approximately 10:08 a.m., Jeff Lueders, Cable Communications and Franchise Services Manager, Media and Communications Office, provided an overview of the Telecommunications Franchise Agreement with New Cingular Wireless PCS, LLC for pole attachment, including what franchise agreements are, provider services, history, process, content of the ordinance, timeline, next steps, and recommendations.

Discussion ensued regarding the anticipated feedback from the public and the concern for noise levels.

5. <u>18-0798</u> Citizens' Government Academy [Will Suarez, Management Fellow, City Manager's Office]

> At approximately 10:16 a.m., William Suarez, Management Fellow, City Manager's Office, presented the Citizens' Government Academy program, including an overview; background; issues, noting inadequate representations from District Nos. 4 and 5 in the City's Committees, Boards, and Commissions (CBC) program; and current CBC members by demographics. Mr. Suarez continued on an analysis of 25 governmental academies, recommendations, and a potential schedule for the academy. He concluded by reviewing outreach elements and timeline.

Discussion ensued throughout regarding communicating with current CBC members to find out their experience with the City's CBC program, a potential day of the week for the academy to meet, inclusion of assisting Council Members in the academy schedule, the importance of productive Government Performance and Finance Committee Minutes July 17, 2018

program structure and format, and offering the academy program in different languages. Discussion continued on outreach to Neighborhood Councils and other governmental agencies, Council Member Hunter's interest in participating in the finalization process, a longer program by adding two more weeks, inclusion of growth, planning, transportation, and equity elements, and inclusion of participatory budgeting. Discussion concluded on academy outcome and end goals and the importance of helping participants understand the government process in meaningful ways.
