Briefing Items

1. 18-0801 Proposals for the Click! Broadband Partnership

At approximately 1:50 p.m., Joanne Hovis, President, CTC Technology and Energy, provided information on the Click! Broadband Partnership proposals, including a background, the Request for Information and Qualifications (RFI/Q) process, and the companies who submitted proposals. She then provided the framework and results on the analysis of the proposals. Ms. Hovis concluded by describing the context of the analysis, noting the 12 policy goals that were adopted by the City Council and Public Utility Board and provided in the RFI/Q; presented recommendations; and described each company's proposal while making note of concerns.

Discussion ensued regarding areas of conflict with the applicants who are moving forward and the 12 policy goals, net neutrality, how to reconcile extra private investment with the goal of continued public ownership, and how to enforce continued public ownership and preserving competition.
