An ordinance amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to add a new Section 1.12.280, entitled "Inclement weather or conditions," relating to the authority of the City Manager and Director of Utilities to grant leave during severe inclement weather or conditions, retroactive to February 11, 2019. #### FIRST READING OF ORDINANCES

11. ORD28576

An ordinance amending Title 13 of the Municipal Code, relating to the Land Use Regulatory Code, by amending various chapters to modify regulations related to accessory dwelling units by allowing detached accessory dwelling units in single-family zoning districts, simplifying regulatory requirements, reducing regulatory barriers, and generally increasing flexibility regarding building design, size, and location, effective May 1, 2019.

MOTION: Council Member Ushka moved to amend Ordinance No. 28576 at Page 2, Line 16, to include the following paragraph:

"WHEREAS the removal of the ADU owner occupancy requirement may result in further opportunities for short-term rentals, which could negatively impact neighborhoods"; and to further amend Exhibit "A" of Ordinance No. 28576 by amending TMC 13.06.150.C.7 at Page 5, to modify the ADU Code to require the property owner to live on-site for approval of a short-term rental of either the house or the ADU (on sites with both).

SECONDED BY: Council Member Mello.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

MOTION: Deputy Mayor McCarthy moved to amend Amended Ordinance No. 28576 at Page 2, Line 16, to include the following paragraph:

"WHEREAS ADUs are intended to be accessory structures clearly smaller than the main house and smaller than typical houses"; and to further amend Exhibit "A" of Amended Ordinance No. 28576 by amending TMC 13.06.150.D.2 at page 6, to replace the proposed tiered maximum ADU size (which allowed up to 1,500 square feet) with a simplified maximum size of 1,000 square feet.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

MOTION: Council Member Hunter moved to amend Amended Ordinance No. 28576 at Page 2, Line 16, to include the following paragraph:

"WHEREAS the City Council recognizes community interest and, in some cases, concerns regarding ADUs and wishes to track implementation outcomes in support of potential future code refinements as appropriate to better support the policy intent"; and to further amend Amended Ordinance No. 28576 by adding a new Section 3 at page 3, line 3, reading as follows: "Section 3. That the City Manager is hereby directed to track ADUs constructed under these regulations and report to the City Council at 12 months, 18 months, three years, and six years after the effective date of these code changes. The review is intended to inform future Council consideration by providing objective data and specific examples addressing topics, including the following: number of ADU permits, number of ADUs built, geographic distribution of permits, ADU size and height, affordability/rent levels, parking provided, and photos and site plans of newly constructed ADUs."

SECONDED BY: Council Member Ibsen.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

ACTION: Amended Ordinance No. 28576, as amended, was set over for final reading on March 19, 2019.

Council Member Beale commented on housing affordability related to proposed Ordinance No. 28576, and stated he is working on possible amendments and a resolution for further Planning Commission review.
