Discussion ensued regarding the vacant positions and which applicants are eligible for the positions.

Northwest Detention Center
[Council Member Blocker, City Council]

At approximately 5:05 p.m., Council Member Blocker stated he would like to conduct a policy development discussion regarding issues related to the

Northwest Detention Center (NWDC). He further stated there will be a series of Committee discussions over the course of the next two to three months on this topic, City staff will provide a draft work plan that addresses the items brought up at today's meeting, and there will be subsequent briefings on the research that will inform any policy decisions that the Committee chooses to make. Council Member Blocker concluded by providing the objectives of the discussions that will be held in the next few meetings and invited Commission on Immigrant and Refugee Affairs (CIRA) members Jefferson Mok and Perla Gamboa-Ravelo to the table to participate in the discussion, including providing questions on what they would like the City to address and how the City can proceed in addressing the concerns.

Discussion ensued regarding a timeline of history showing where the City has been with the NWDC, a letter submitted to the Committee from La Resistencia (formerly named NWDC Resistance), visiting and speaking with detainees of the NWDC, how to tour the NWDC without the participation of Immigration and Customs Enforcement, a letter submitted to all Council Members from NWDC subcommittee of the CIRA, reviewing what the City has done in the past and the next steps, challenges, service providers the City currently contracts with where the contracts can be amended, policy issues, the NWDC's emergency evacuation plan, land use controls, and level of capacity for City staff to do in-depth research. Discussion continued on receiving a background document of the origination of the NWDC, provision of items the City has or hasn't done in regards to permits, options for cost reimbursement for emergency services, the City's specific ability to require humanitarian standards and the ability to oversee them, what would be credible authentic oversight, what power the City has to do something about oversight issues, regulation of the business license for NWDC and the conditions, having a legal review of the amortization as a land use tool to amortize the use out of Tacoma, advantages of having the NWDC in Tacoma, and clarification of what elected officials can and cannot do independently from the City.

Discussion concluded on issues that detainees have described regarding the NWDC, learning what the NWDC regulations are, provision of a response in regards to the oversight of food, and working with advocacy groups to obtain outside medical information of detainees with specific information redacted.

Other Items of Interest


