3.	<u>19-0084</u>	Update on Namatad [Pat Beard, Project Manager, Community and Economic Development]
		At approximately 10:08 a.m., Pat Beard, Project Manager, Community and Economic Development (CED), introduced Matt Tolentino, Assistant Professor, University of Washington-Tacoma.
		Council Member Ushka arrived here, at 10:11 a.m.
		Mr. Tolentino provided his background, background of the project, and the challenges faced by firefighters in the field. He described Firefly, which is a platform designed to assess building fires or other dangerous situations; the components of Firefly; continuous development, including fire response, enabling smart buildings, identifying exposure risk with autonomous drones, and conducting field evaluations; and the annual cost to fire services. Mr. Tolentino concluded by reviewing adjacent market opportunities, target markets, and next steps.

4. <u>19-0085</u> Development and Discussion of the Economic Development Strategic Plan [Jeff Robinson, Director, Community & Economic Development, and Chris Mefford, President and CEO, Community Attributes Inc.]

> At approximately 10:55 a.m., Jeff Robinson, Director, CED, provided background on the City's Economic Development Strategic Action Plan, including realignment of the department into a business, services and workforce partnerships division and the creation of an economic development services division; future plans on placing more emphasis on maintaining and expanding current small and mid-size businesses; and introduced Chris Mefford, President and CEO, Community Attributes, Inc.

Mr. Mefford reviewed his background with the City and the regional work currently being done. He presented the Strategic Plan working draft schedule, covering landscape analysis, an economic profile, stakeholder outreach, and the Strategic Plan. He concluded by outlining the next steps and how they plan on moving forward.

Discussion ensued regarding community outreach, ways to utilize data from past economic development strategies, recruiting businesses to utilize empty spaces with a focus on downtown Tacoma, introducing incentives for small and medium businesses, and how to make the City an employment center. Discussion concluded on a request for an update on the Mayor's Youth Advisory Council.
