3. <u>19-0490</u> City Events and Recognitions Committee Interviews [Doris Sorum, City Clerk]

At approximately 10:02 a.m., Doris Sorum, City Clerk, stated the Committee would be interviewing two applicants for the City Events and Recognitions Committee vacancies and reviewing written response from Rhonda Ware, who was unable to attend the meeting.
