Briefing Items

2. <u>19-0063</u>

Status of the Southern Resident Killer Whales (Orcas) and Salmon Recovery [Laura Blackmore, Deputy Director, Puget Sound Partnership; James Parvey, Office of Environmental Policy and Sustainability]

At approximately 4:33 p.m., Laura Blackmore, Deputy Director, Puget Sound Partnership, presented an update on the status of the Southern Resident Killer Whales (Orcas) and salmon recovery. She reviewed the causes of the population decline and the Orca Task Force implemented by Governor Jay Inslee to develop an action plan to recover the orca population.

Ms. Blackmore presented the Orca Task Force recommendations to increase prey, decrease vessel interference, and reduce the threat of contaminants. John Burk, Science and Engineering Division Assistant Manager, Environmental Services, and Anita Gallagher, Regional Relations Manager, Tacoma Public Utilities, outlined the next steps for the Orca Task Force, what cities can do, and what actions Tacoma is already taking.

Discussion ensued regarding educating the public, collaborating with other partners such as local tribes and non-profit organizations, and revitalizing local habitats and river passages.

3. <u>19-0064</u>

Detached Accessory Dwelling Unit Update
[Elliott Barnett, Senior Planner, Planning and Development Services]

At approximately 5:06 p.m., Brian Boudet, Planning Manager, Planning and Development Services (PDS), made introductory remarks regarding past discussion of the Detached Accessory Dwelling Unit (DADU) plan, and introduced Mia Navarro, Management Analyst III, Office of Equity and Human Rights. Ms. Navarro presented some equity considerations, historical instances of racial inequity in housing and future ADU/DADU considerations. Elliott Barnett, Senior Planner, PDS, provided a list of potential modifications to the proposal, including clarifying maximum size, reducing minimum lot width, defining green features for height bonus, clarifying parking access standards, updating design standards, owner occupancy, and affordability incentives.
