Briefing Items

2. 19-0116

iDEA School Permeable Pavement Project [Jessica Knickerbocker, Engineer, Environmental Services]

At approximately 4:32 p.m., John Burk, Environmental Services Division Assistant Manager, ES Science and Engineering, introduced Matthew Lonsdale, Teacher, Science and Math Institute, John Stark, Director, Washington Stormwater Center, and Jessica Knickerbocker, Principal Engineer, ES. Ms. Knickerbocker presented the permeable pavement advancements project at the School of Inudstrial Design,

Engineering, and Art (iDEA), including an overview, history of permeable pavements, background on developing standard specifications, project issues and goals, results from a survey on permeable pavement use, and types of permeable pavement. Mr. Stark described the material testing, pavement monitoring, and water quality monitoring. Mr. Lonsdale presented the goals, benefits, and student solutions of the iDEA classroom program; and the class's partnership with Orcas Love Raingardens, a collaborative partnership between local government, public services, and non-governmental organizations. Ms. Knickerbocker concluded by reviewing the project's next steps and project partners.

Discussion ensued regarding permeable asphalt versus permeable concrete; scope of the project; and material durability testing.

Chair Mello stated Item No. 4, Joint Base Lewis-McChord Airport Compatibility, would be presented before Item No. 3, Right of Way Residential Electric Vehicle Charging Pilot Program.

4. 19-0119 Joint Base Lewis-McChord Airport Compatibility
[Larry Harala, Associate Planner, Planning and Development Services]

At approximately 5:00 p.m., Larry Harala, Associate Planner, Planning and Development Services (PDS), presented on the Joint Base Lewis-McChord (JBLM) Airport Compatibility Overlay District (ACOD), including an overview, noting proposal, prior actions, and requested actions; intent; the JBLM joint land use study area; the Accident Prevention Zone II (APZ); the proposed JBLM ACOD; existing zoning; land use compatibility with regards to the JBLM clear zone and APZs; public comments and process; and proposed prohibited uses for commercial and industrial uses. He concluded by reviewing a summary of the proposal and requested action.

Discussion ensued regarding best ways to decide what would constitute a prohibited use and how to help areas that would become prohibited use.

3. 19-0118 Right of Way Residential Electric Vehicle Charging Pilot Program [Joe Graff, Development Specialist, Planning and Development Services; Jana Magoon, Planning Manager, Planning and Development Services]

At approximately 5:24 p.m., Jana Magoon, Planning Manager, PDS, introduced Joe Graff, Development Specialist, PDS, and presented on the Residential Right of Way Electric Vehicle (EV) Charging Pilot Program, including an overview; background; issues; outreach; and a health, equity, and sustainability analysis. She concluded by reviewing recommendations and next steps.

Discussion ensued regarding current outreach, best ways to install the chargers, and how to reinforce the charging and parking area.
