Clean Fuel Standard

[Craig Kenworthy, Executive Director, Puget Sound Clean Air Agency]

At approximately 4:32 p.m., Craig Kenworthy, Executive Director, Puget Sound Clean Air Agency, presented on the clean fuel standard (CFS), including the Agency's greenhouse gas emission targets; Tacoma's exposure to sea level rise; potential shifts in the Puyallup watershed; pollution sources; background; reasons for a CFS; what a CFS is; what it would entail; how it works; today's cleaner fuels; carbon intensity; biodiesel and electricity pathways; who receives credits; high-level economic impacts; public health and equity; fuel price impacts; a summary; and next steps.

Discussion ensued throughout regarding race and economic factors, how credits are achieved, selling credits and use of that revenue, the price of diesel versus gas, opponents of the ideas, local economic benefits, and a timeline moving forward.
