Transportation Commission Work Plan and Accomplishments [Jennifer Kammerzell, Principal Engineer, Public Works]

At approximately 4:33 p.m., Jennifer Kammerzell, Principal Engineer, Public Works (PW), made opening remarks and introduced Jane Moore, Co-Chair, Transportation Commission (TC), and Gerrit Nyland, Co-Chair, TC. Together, they presented the Transportation Commission 2019-2020 work plan and accomplishments, including an overview, background, community involvement and representation, project participation, the six-year transportation improvement program annual ammendment, street initiative progress reporting, capital project planning and grant review, agency coordination, State Route 167 and I-5/Tacoma Mall direct access, commission coordination, transportation master plan biennial amendments, TC initiatives, and a request for a recommendation from the IPS Committee.

Discussion ensued throughout regarding encouraging more bike lane usage, increasing funding and services for Pierce Transit and public transportation, and the Vision Zero plan and making streets safer.

Sidewalk Data Collection and Sidewalk Program Update [Reid Bennion, Management Analyst II, Public Works]

At approximately 5:11 p.m., Reid Bennion, Management Analyst II, PW, introduced Carrie Wilhelme, Planner Associate, PW, and together they presented the sidewalk data collection and Sidewalk Program update, including an overview; background; walking audits; pedestrian/bike collision counts; the Sidewalk Program, noting program type and funding, 2019-2020 changes, program delivery issues, and new prioritization process; equity index values; and next steps.

Discussion ensued throughout regarding having parent/teacher organizations conduct data collection, doing audits for more K-9 schools, sidewalk maintenance responsibilites for property owners, inspection and enforcement programs of other cities, and future ways to deal with sidewalk complaints.
