#### 4 19-1322 Urban Forest Management Plan

[Jim Parvey, Division Manager; Mike Carey, Urban Forest Program Manager, Office of Environmental Policy and Sustainability]

At approximately 5:46 p.m., Jim Parvey, Division Manager, Office of Environmental Policy and Sustainability (OEPS) made opening remarks. Mike Carey, Urban Forest Program Manager, OEPS, presented the Urban Forest Management Plan, phase two, including agenda, overview, framework, layout and timetable, and next steps.

Chris Peiffer, Director of Urban Forestry Consulting Services, PlanIT Geo, presented the action summary goals, noting management policy, capacity and training, funding and authority, inventory and planning, risk and disaster management, and community engagement.

Discussion ensued throughout regarding the resolution coming to the City Council meeting on December 3, 2019, number of trees planted in Tacoma neighborhoods, time needed to align tree protection and design standards in TMC 13.06.502.E, contracting with a nonprofit group in the area, maintenance corridors for trees, prioritizing census tracks for planting corridors, and next steps.
