FIRST READING OF ORDINANCES

5. ORD28683

An ordinance authorizing the execution of an amendment to the agreement with RockTenn, CP LLC, d.b.a. WestRock CP LLC, to extend the agreement for an initial period of one year, with the option to renew for four additional one-year periods. [Scott Dewhirst, Water Superintendent; Jackie Flowers, Director, Tacoma Public Utilities]

ACTION: Ordinance No. 28683 was set over for final reading next week.

UNFINISHED BUSINESS

There was no unfinished business.

REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli provided an update on the City's Rental Assistance Program, stating Living Access Support Alliance (LASA) administers the Program, 179 payments have been made totaling \$160,163.15, applications for round two of lottery funding resulted in 146 unduplicated applications, LASA expects to complete initial contacts with all applicants by end of day, and applicants may

receive a one-time payment of up to \$1,000 based on a criteria. She concluded by stating LASA is partnering with Pierce County's Emergency Rental Assistance Program to ensure that all applicants maximize their access to rental assistance resources, and the City's Rental Assistance Fund at the Greater Tacoma Community Foundation has received 12 gift donations totaling \$2,800.

Discussion ensued regarding the Rental Assistance Program, including the number of payments made, the total amount paid out, the process, and consideration of additional lottery funding rounds as well as updates to the process and sharing the results.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

There were no standing committee reports given.

Mayor Woodards shared that at study session today, the City Council voted to support the Community Commitment for Safe Youth in partnership with Graduate Tacoma; and stated Tacoma faces a projected loss of approximately 4,000 summer program slots that provide youth with safe and supportive spaces, and because of this, Graduate Tacoma reached out to the City and other community steakholders to work together in developing guidance that centers on four basic principals of how Tacoma can support youth this summer and beyond. She concluded by announcing the four principals, including Create and Nurture Welcoming Environments; Stop, Listen, and Engage with Youth; Check your Emotions; and Give Grace; she announced that if you are a business owner or individual that would like to take this pledge, you will get a sticker to place in your business or car so youth know where a safe space is; and provided a website where community members can sign up to participate.

Mayor Woodards further announced that she signed on to former President Barack Obama's Mayor's Pledge, to support police reform that is done in partnership with the Obama Foundation and My Brother's Keeper; the Mayor's Pledge asks for cities across the nation to take the following actions: review your police use of force policies; engage your communities by including a diverse range of input, experiences, and stories in your review; report the findings of your review to your community and seek feedback; and reform your community's police use of force policies.

MOTION: Deputy Mayor Blocker moved to excuse Council Members Beale and McCarthy from the meeting.

SECONDED BY: Council Member Thoms.

ACTION: Voice vote was taken and carried. The motion was declared adopted.
