At approximately 4:46 p.m., Doris Sorum, City Clerk, informed the Committee they will be interviewing nine applicants for the Human Rights Commission (HRC), and that there are seven positions vacant, all consisting of unexpired terms. She further stated that these interviews were originally scheduled for March 26, 2020, but had to be rescheduled due to COVID-19 and the cancellation of standing committee meetings.

The Committee interviewed Michealea Lemons, Norman Brickhouse, Andre Jimenez, C. Ivan Johnson, Milo Milligan, Alexander Scheel, Verda Washington, Amanda Westbrooke, and Keshreeyaji Oswal.
