2021-2022 Proposed Fee Schedule

[Reid Bennion, Lead Budget Analyst, Finance]

At approximately 10:43 a.m., Reid Bennion, Lead Budget Analyst, Finance, presented the 2021-2022 fee schedule update, including a summary of changes; unneeded fees that were removed; updated fees; new fees, noting Equity 101 training for community members and public records requests for body camera video; and fees updated and moved from the Tacoma Municipal Code to the fee schedule.

Discussion ensued regarding fees for public records requests for body camera video; Equity 101 training; fees for other public disclosure requests; special events permit fees; outreach to past permit applicants; revenue generated from fees; Basic Life Support, Advanced Life Support, and transport fees; and the reduction in fire engine costs.

Mr. Berry presented the responses to questions raised at the October 20, 2020, Government Performance and Finance Committee meeting, including the rate history for the five largest Tacoma Power customers, the history of revenues from wholesale customers, and the history of the Tacoma Power system average of rate increases.

Discussion ensued throughout regarding average rate increases, wholesale revenue, how the market affects rates, renewable and emission-free power, proposed rate increases, business rate increases, and the utilization of revenue.
