4. <u>20-0051</u> Economic Development Committee 2019 Year-End Report [Tadd Wille, Executive Liaison to the Economic Development Committee]

At approximately 10:06 a.m., Tadd Wille, Deputy City Manager, presented the 2019 Year-End Report, including informational briefings and requests for action taken throughout the year, categories, and additional topic areas that were not reviewed.

At approximately 10:11 a.m., Doris Sorum, City Clerk, informed the Committee they will be interviewing two applicants for the Tacoma Arts Commission, who were unable to attend the interviews at the November 12, 2019 meeting, where the Committee requested to interview them in person. She concluded by stating there is one "At-Large" position open, which is an unexpired term to expire December 31, 2022.

Integrating Local Revitalization Financing and Transportation System Improvements [Elly Walkowiak, Assistant Director, Community and Economic Development; Dana Brown, Assistant Division Manager, and Eric Huseby, Parking Services Manager, Public Works]

At approximately 10:26 a.m., Chair Thoms made opening remarks. Elly Walkowiak, Assistant Director, Community and Economic Development, introduced Dana Brown, Assistant Division Management, Public Works, and presented the local revitalization financing (LRF) and transportation system improvements, including an overview; LRF program summary; LRF investment best practices; the proposed transportation system investment model, noting three steps; five evaluation indicators; and investment model advantages. Mr. Brown reviewed the comparative analysis of four downtown Tacoma areas using the investment model and evaluation indicators, the integration of parking study data, and key points.

Discussion ensued throughout regarding boundaries and constraints on the LRF funds, the "Graffiti Garage" parcel, data sets of predictability, general boundaries of the analysis locations, spaces lost in the Dome district, and ride share services.

At approximately 11:14 a.m., Amy McBride, Tacoma Arts Administrator, Tacoma Venues & Events (TVE), introduced Lisa Jaret, Tacoma Creates Program Manager, and Clarissa Gines, Tacoma Creates Coordinator, TVE. Ms. McBride presented the Tacoma Creates Advisory Board appointment process, including background, recommended timeline, outreach, criteria, and a statistical breakdown of applicants.
