At approximately 10:10 a.m., Doris Sorum, City Clerk, informed the Committee they will be interviewing six applicants for the City Events and Recognitions Committee and that Wilton Waverly was the seventh but withdrew. She further stated that there are currently six positions vacant, all consisting of unexpired terms; these interviews were originally scheduled for May 12, 2020 but had to be rescheduled due to COVID-19 and the cancellation of meetings at that time; and the vacant positions include At-Large Nos. 5 and 6, and Council District Nos. 1, 2, 4, and 5. Ms. Sorum further informed the Committee that Ashley Jones has moved out of District No. 4 where she is currently assigned, and to continue to serve, Ms. Jones would need to be reassigned to District No. 3, where she can continue to serve with the same term length.

The Committee interviewed Ann Zimmerman, Luis Alonzo, Stephanie Caldwell, Aleecia Ramsey-Gonzalez, Jessica Johnston, and Rosie Delcid-Castillo.

Discussion ensued regarding the applicant that requested reassignment and vacant positions.
