## **Briefing Items**

1. <u>20-0091</u> Economic Development Strategic Plan

At approximately 12:09 p.m., Jeff Robinson, Director, Community and Economic Development (CED), introduced Elly Walkowiak, Assistant Director, CED, and presented the Economic Development Strategic Plan, including an overview, context, advancing Tacoma 2025, values and approach, and Community Attributes Inc.'s economic development pyramid. Ms. Walkowiak presented the focus areas and objectives, including business retention, expansion, and recruitment; small businesses and entrepreneurship; workforce development and human capital; neighborhood business district revitalization; Downtown Tacoma; commercial and industrial property activation; business and development climate; and placemaking and City image. She reviewed measures that will be used to benchmark and assess progress.

Ms. Walkowiak concluded by reviewing the implementation of the plan and the unifying message.

Discussion ensued regarding reaching out to Pierce County, targeted sectors, drawing businesses to the City, and national outreach.

#### 3. <u>20-0093</u> Tacoma Soccer Stadium Proposed Letter of Intent

At approximately 12:50 p.m., Steve Victor, Deputy City Attorney, introduced Debbie Terwilleger, Planning Director, Metro Parks Tacoma, and presented the Tacoma soccer stadium proposed letter of intent, including an overview, background, the soccer stadium site plan, a projected timeline, the letter of intent, the scope of the letter of intent, soccer stadium funding plan, public benefits identified in the letter, and economic benefits identified by consultants. Ms. Terwilleger concluded by reviewing the next steps.

Discussion ensued regarding sports equality, ownership of the land and stadium, engaging the school district, the feasibility study, fiscal responsibilities outlined in the letter of intent, private funding versus public funding, funding for other stadiums, and reserve spending.
