## SPECIAL MEETING

### CALL TO ORDER

Mayor Woodards called the special meeting to order at 2:03 p.m.

### ROLL CALL

- Update on the City of Tacoma's financial status; and
  - Temporary Emergency Shelter Site Transition.

City Manager Elizabeth Pauli introduced Linda Stewart, Director, Neighborhood and Community Services. Ms. Stewart provided an update on the Tacoma Emergency Micro-Shelter site, including background, current and new locations, budget, timeline, and outreach.

Discussion ensued regarding capacity of the shelter, how long the shelter can be run, and how the shelters function as part of the neighborhood.

City Manager Pauli introduced Katie Johnston, Budget Officer, Finance. Ms. Johnston presented a financial update, including the estimated 2020 revenue impact, planning for 2020 and 2021, and economic projections.

Discussion ensued regarding possible budget impacts when the State Legislature is back in session.

Mayor Woodards reminded the Council that Governor Inslee was issuing guidance on Phase One of re-opening the State.

Council Member Walker recognized National Teacher Appreciation Week.
