REPORTS BY THE CITY MANAGER

<u>21-0157</u> Update on Systems Transformation.

City Manager Elizabeth Pauli informed everyone that she will begin providing an update on systems transformation during City Council meetings, likely during the second and fourth Tuesdays of the month; reviewed an update on systems transformation, including new items, noting Heal the Heart of Tacoma, new policies and transforming existing programs, current state analysis of the TPD, administrative changes and process improvements to increase transparency in policing, and the legislative agenda at local, State, and Federal levels; and stated that all of the updates can be found on the transformation webpage at www.cityoftacoma.org/transform. She concluded by addressing comments received regarding food security, stating the City was successful in distributing \$900,000 in Coronavirus Aid, Relief, and Economic Security Act funding to food banks in 2020 and the food bank funding has been increased in 2021.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Thoms, Chair of the Economic Development Committee, reported at the January 12, 2021, meeting, the Committee received presentations on the status and prospects for Federal funding for COVID-19 recovery, and on changes to the special events competitive funding process; at the January 26, 2021, meeting, the Committee elected the Chair and Vice Chair, and received a presentation on training and employment program updates; and at today's meeting, the Committee received a presentation on

WorkForce Central and City coordination. He continued by stating that the City is hosting a Black Business Empowerment Panel discussion on February 17, 2021, and informed everyone that they can register for free at bbetacoma.eventbrite.com. Council Member Thoms concluded by stating the February 23, 2021, meeting has been cancelled, and the next meeting will be held on March 9, 2021, through Zoom, and will include a presentation on the Port of Tacoma's strategic plan, and an informational briefing on hotel workers recall rights.
