Community Vitality and Safety Committee

Council Member Ushka, Chair of the Community Vitality and Safety Committee (CVS), reported at the September 23, 2021, meeting, the Committee received presentations on the Washington House Bill 1590 outreach plan and the Commission on Immigrant and Refugee Affairs 2021 annual report and recommendations, and held a discussion on the committees, boards, and commissions under CVS. She concluded by stating the next meeting will be held on October 14, 2021, at 4:30 p.m., through Zoom, and will include presentations on the youth violence prevention assessment and transformation efforts.

Economic Development Committee

Council Member Thoms, Chair of the Economic Development Committee, reported at the September 28, 2021, meeting, the Committee conducted interviews for the Tacoma Creates Advisory Board; and today's meeting was cancelled. He concluded by stating the next meeting will be held on October 26, 2021, at 10:00 a.m., through Zoom, and will include a presentation on Tacoma Public Utilities' Economic Development efforts.

Council Member Hines addressed comments from the Public Comment and Community Forum periods, regarding in-person meetings and the Multi-Family Property Tax Exemption Program.

Council Member Ushka expressed gratitude to members of the community for helping clean up the Khmer Theravadin Buddhist Temple.

Mayor Woodards provided an update on COVID-19, including how the Tacoma-Pierce County Health Department (TPCHD) continues to collaborate with Pierce County business and hospitality leaders to consider ways to get more people vaccinated; the isolation and quarantine facility at the Lighthouse Senior Center has extended its operations until November 30, 2021; the TPCHD has a new data dashboard on their website that provides more information on COVID-19; transmission in the community is still high and is spreading more in areas with low vaccination rates; data on vaccinations rates and age ranges; and encouraged everyone to continue to wear their masks, wash their hands, and turn to reliable sources for questions regarding the vaccine.
