Community Vitality and Safety Committee

Council Member Ushka, Chair of the Community Vitality and Safety Committee, reported at the October 14, 2021, meeting, the Committee received presentations on the Youth and Young Adult Violence Reduction Program and systems transformation; and at the October 28, 2021, meeting, the Committee received presentations on the Tacoma Public Library's Hilltop and Eastside feasibility study, the 2021-2022 housing and urban development annual action plan, and a homelessness update. She concluded by stating the next meeting will be held on November 4, 2021, at 4:30 p.m., through Zoom, and will include interviews for the Community's Police Advisory Committee.

Council Member Ushka expressed appreciation for law enforcement staff, including the Tacoma Police Department (TPD), for their work in resolving an incident that had occurred recently.

Mayor Woodards also expressed appreciation for the TPD and law enforcement as well as for Council Member Ushka for her leadership in her district at this time. She further expressed appreciation for the Islamic Center of Tacoma, Associated Ministries of Tacoma, and Tacoma Community College, for holding an interfaith solidarity gathering against attacks on places of worship on October 31, 2021. She continued by providing information on COVID-19 booster shots, including where residents can receive them; the Centers for Disease Control recommendations; vaccination rates by age range; the Tacoma-Pierce County Health Department's virtual community presentation on Thursday, November 4, 2021, to discuss the safety and effectiveness of the vaccine; case rates; and how local businesses can help lower case rates by following the vaccination and mask mandates,

where applicable. Mayor Woodards concluded by reminding everyone that today is Election Day and encouraging all residents to vote.
