City Manager Elizabeth Pauli reported that the Transportation Improvement Board notified the City of two successful grant applications, including a \$4 million grant for the second phase of the East 64th Street project, which extends from McKinley Avenue to Portland Avenue; and a \$297,000 grant for construction of missing link sidewalks on South Yakima Avenue, between South 67th and South 70th Streets.

She concluded by stating the next meeting will be held on December 9, 2021, at 4:30 p.m., through Zoom, and will include a presentation on police transformation and a follow-up on unlawful camping in the City ordinance options.
