# **Briefing Items**

#### 1. 21-0562 Home in Tacoma Initiative Discussion

At approximately 12:02 p.m., Peter Huffman, Director, Planning and Development Services, presented on the Home in Tacoma Project, including an overview and request for City Council guidance on the review process and timeline, background, proposed next steps, information available online at www.cityoftacoma.org/homeintacoma, upcoming public information sessions, and staff contacts.

Discussion ensued regarding providing additional time for City Council review.

Deputy Mayor Blocker arrived here, at 12:14 p.m.

Discussion continued regarding management, analysis, and impact of public comments; proposed timelines for review, public hearings, and City Council discussion and consideration; urgency of the housing crisis; consideration of design standards in both phases; historic inequities; encouraging higher density in underdeveloped areas; public sentiment and trust; the original

recommendations and revisions now under consideration; changes to the original timeline; clarifying the purpose, process, phases, and timelines for the community; outreach to marginalized communities; an option for a Committee of the Whole discussion; and next steps for staff to prioritize specific issues.

#### 2. <u>21-0563</u> American Rescue Plan Fund Update

At approximately 1:22 p.m., Reid Bennion, Lead Budget Analyst, Finance, presented an update on the American Rescue Plan Act (ARPA) fund, including an agenda, uses for \$61 million of direct City funding, the structure and objectives for direct City assistance, ARPA spending objectives, proposed distributions for 2021, Council Committee alignment, the proposed reporting structure, and a timeline for next steps.

Discussion ensued regarding the upcoming legislation, tracking and reporting fund usage, items for immediate action, Council Member priorities and specific projects, funding to address homelessness and housing, the housing tax, restoring Tacoma Public Library funding, additional briefings at upcoming Standing Committee meetings, and City Council approval of the funding buckets.

#### 3. <u>21-0565</u> Amendment to the six-year Comprehensive Transportation Improvement Program

Council Member Beale presented a proposed motion to amend Ordinance No. 28769 at tonight's meeting, noting that it will be added to the final reading of the ordinance next week, and described the addition of six projects.

Discussion ensued regarding the scope of specific projects.

#### 3a. 21-0576 Manuel Ellis Update

Fred Scruggs, Assistant Police Chief, Tacoma Police Department (TPD), presented an update on the Manuel Ellis case, noting the Washington State Attorney General's decision to charge three TPD officers, the City's process to request information from investigative bodies, issuance of a notice of investigation to the officers, receipt of investigative packets from the Washington State Patrol and Pierce County Sheriff's Department, and communications with the Attorney General's Office. City Manager Elizabeth Pauli further stated that written updates will also be provided to the City Council and posted on the City website.
