Advanced Electric and Water Meters Program Update

[Joe Tellez, Chief Technology Officer; Andre Pedferri, Advanced Meter Program Manager; and Matt Hubbard, Advanced Meter Program Workstream and Change Management Lead, Tacoma Public Utilities]

At approximately 10:17 a.m., Joe Tellez, Chief Technology Officer, Tacoma Public Utilities (TPU), reviewed TPU's utility modernization strategy, noting the advanced metering deployment, digital engagement, advanced data analytics, workforce management, cybersecurity, energy imbalance market, and the Geospatial systems. Matt Hubbard, Advanced Meter Program Workstream and Change Management Lead, TPU, presented an overview of the advanced electric and water meters program, including the advanced meter infrastructure components; the advanced metering deployment budget, noting grant funding, total project cost, a rate impact analysis, and an opt-out policy; an advanced metering business case, noting return on investment evaluation and conclusions; and responses to community member questions. Mr. Hubbard further outlined customer and operational benefits, including utility benefits, noting meter upgrades, improved forecasting and modeling, improved asset management and resiliency, and improved operational efficiency and safety; customer benefits, noting monthly billing, budget billing, prepay options, selectable bill due dates, and enhanced outage detection; additional benefits as a TPU customer and as a TPU engineer; and target dates for 2021.

Discussion ensued regarding support from the Public Utility Board, having forward thinking and recognizing the benefits of advanced meters, 2016 study of customers with broadband access, the additional cost increase each year for the next ten years, when the original meters would need replacement if the program is halted, and real-time knowledge of usage.
