2. [21-0542](#) Interviews for the Public Utility Board
[Doris Sorum, City Clerk]

At approximately 10:04 a.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing one applicant who was unable to attend the Public Utility Board (PUB) interviews at the May 18, 2021, meeting where the other two applicants, Elly Claus-McGahan and Shawna Grambo, were interviewed. She concluded by stating that there is one position available, to serve a five-year term.

The committee interviewed Holland Cohen.

Discussion ensued regarding applicant qualifications, importance of the PUB, the Vice Chair's absence and potentially waiting to hold the vote until she is present, consequences of waiting, the on-boarding process for new members, and the preference to recommend an appointment today.

MOTION: Council Member Thoms moved to recommend the appointment of Holland Cohen to the Public Utility Board to serve a five-year term, effective July 1, 2021, to expire June 30, 2026.

Discussion continued regarding applicant's qualifications for other boards and commissions, efficiencies of utility delivery and services, the housing market, development costs, integrating economic development, if there is a list of prior applicants and reaching out to them when openings occur.

At approximately 10:31 a.m., Mike Slevin, Director, Environmental Services, introduced Frankie Johnson, Chair, and Deanna Seamen, Vice Chair, Environmental Services Commission (ESC), and provided an overview of the ESC, including an agenda; the department mission statement; purpose of the

ESC; member composition, noting the classes and interests of utility customers; key points of the ESC charter; and examples of work done by ESC members.

Discussion ensued regarding a request for more information on how rates are developed, commission terms and open positions, recruitment process, rate classes, commission work outside of the rate cycle, presenting how rates are developed to the City Council, and diversity of the ESC.

Tacoma Creates

At approximately 10:53 a.m., Amy McBride, Arts Administrator, and Lisa Jaret, Program Manager, Tacoma Venues and Events, gave a presentation on Tacoma Creates sales tax revenue, including an overview, Tacoma Creates legislation and primary funding goals, 2019 startup phase, 2020 inaugural funding, a tour of the Tacoma Creates website, the upcoming 2021 to 2022 funding cycle, cultural access tax dollars; and expenses.

Discussion ensued regarding the participatory budget, equity index, funding for groups without non-profit status, transit and transportation funding, transportation funding options for downtown specific organizations for areas not accessed by transit, budget drops over the next fiscal year, increased personnel and employee related costs, partnership with Tacoma Public Library, the Tacoma Creates Advisory Board and funding approvals, and sales taxes.
