At approximately 10:10 a.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing six applicants for the Tacoma Arts Commission and reviewing one written response from Heide Fernandez-Llamazares, who is seeking reappointment; that Bronwyn Dorhofer and Sara Freeman have withdrawn from consideration; and that there are five positions available including At-Large Nos. 1 and 8, Professional Nos. 3 and 4, and the Working Professional Artist position.
