Briefing Items

1. <u>21-1132</u> Vision Zero Action Plan and Speed Reduction Study Update [Carrie Wilhelme, Senior Transportation Planner, Public Works]

At approximately 5:01 p.m., Carrie Wilhelme, Senior Transportation Planner, Public Works, presented an update on the Vision Zero Action Plan, including a presentation overview; Vision Zero overview, noting the traditional approach versus Vision Zero and fatality levels at various speeds; background; deliverables, noting the Vision Zero Action Plan, the updated Local Roadway Safety Plan, Speed Reduction Study, and the Racial Equity Action Plan; speed reduction; a timeline; and next steps.

Discussion ensued regarding areas of application, impacts of excessive speed and the lack of sidewalks, whether a cost analysis for new signage has been completed, enforcement, speed radar use by Pierce County, budgeting for other areas, whether crash data was utilized in the Speed Reduction Study, utilizing the Equity Index, and the data dashboard.

2. <u>21-1133</u> FEMA Floodplain Code Updates

[Sue Coffman, P.E., Building Official, Planning and Development Services]

At approximately 5:30 p.m., Sue Coffman, Building Official, Planning and Development Services, presented an update to the Federal Emergency Management Agency (FEMA) National Flood Insurance Program (NFIP) Code Amendments, including scope; background, noting FEMA's NFIP and the Department of Ecology Flood Hazard Division; issues; proposed revisions; City floodways; health, equity, and sustainability analysis; outreach; and next steps.

Discussion ensued regarding the areas affected.
