Mayor Woodards recognized Theresa Evans, Community Advocate, and presented the Compassionate Tacoma recognition to Evans.

City Manager Elizabeth Pauli provided opening remarks on systems transformation and introduced Mike Slevin, Director, Environmental Services (ES). Slevin introduced Lewis Griffith, Solid Waste Management Division Manager, ES, and provided background information on ES's strategic plan, and equity and transformation efforts. Griffith presented the ES departmental transformation highlight, including solid waste education outreach and engagement, noting the City Council priority area regarding access to services, context, actions, and transcreation; and equitable outreach and engagement, noting the City Council priority area regarding access to services, and the Recycle Reset Community Ambassador Program.

Griffith further reviewed how the workforce reflects the community, noting the racial and demographic diversity of ES employees, the ES Equity Team, and the team's recruitment and retention subcommittees; purposeful outreach and engagement; equitable service delivery; and the departmental look forward, noting ongoing efforts. City Manager Pauli concluded by presenting recent accomplishments, upcoming items, and the transformation timeline and history.

An amended ordinance amending Chapter 11.05 of the Municipal Code, relating to Model Traffic Ordinance, by adding a new Section 11.05.133, entitled "Unlawful exhibition of speed attendance prohibited", relating to prohibiting attendance at unlawful exhibitions of speed.

MOTION: Council Member Blocker moved to amend Ordinance No. 28811 on page 1, line 22, to replace the number "90" with "30," to read as follows:

"WHEREAS any person who operates a motor vehicle in or during an unlawful exhibition of speed is guilty of a misdemeanor, which is punishable by up to 30 days in jail, up to a \$1,000 fine, or by both such imprisonment and fine, and"

He further moved to amend Exhibit "A" of Ordinance No. 28811 on page 4, line 16, to replace the number "90" with "30," to read as follows:

"A. Any person (1) who has actual or constructive knowledge that he or she is in attendance of an unlawful exhibition of speed; and (2) who has actual or constructive knowledge that an unlawful exhibition of speed is occurring, has occurred, or is about to occur; and (3) was there with the intent to observe or support or encourage the unlawful exhibition of speed, is guilty of a misdemeanor, which is punishable by up to 30 days in jail, up to a \$1,000 fine, or by both such imprisonment and fine."
