REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli reported that the City has been awarded two grants, including one for seismic retrofits for the Lincoln Avenue Bridge and one for the East 34th Street Bridge, for roadway deck repair and installation of seismic stiffeners; that 46 Ford Crown Victorias used by the Tacoma Police Department have been replaced with Ford hybrid electric vehicles, noting a 50 percent fuel savings, and 27 additional Ford Police Interceptors are on order to replace the remaining Ford Crown Victorias that are more than 10 years old; and that the Human Resources Department hosted a recruiting and hiring event today in partnership with WorkSource Pierce, noting that the event reached capacity within a week of being advertised, with 125 attendees and a wait list with over 21 people, and that those who attended were exposed to a large number of professional careers and featured jobs.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Blocker, Chair of the Economic Development Committee, reported at the July 12, 2022, Committee meeting, the Committee received a presentation on the World Trade Center Tacoma association; and on July 26, 2022, the Committee conducted the first round of interviews for the Equity in Contracting (EIC) Advisory Committee and received a presentation on the United States Environmental Protection Agency Brownfields Job Training Grant. He concluded by stating the next meeting will be held in a hybrid format on August 9, 2022, at 10:00 a.m., and will include additional interviews for the EIC Advisory Committee and a presentation on Sister Cities.

Mayor Woodards informed everyone that the United States (U.S.) Maritime Administration awarded Secure All-around Flotation Equipped (SAFE) Boats a grant to purchase equipment for its Tacoma shipyard, noting that with the company's match there will be an additional \$1 million investment in their local operation, 75 full-time staff are expected to be brought on, the company is under contract with the U.S. Navy and will be building ships for use by the government of Ukraine, SAFE Boats' long-term plans are to sustain the Tacoma shipyard beyond the contract, the City's Community and Economic Development Department has worked closely with many partners since 2018 to bring SAFE Boats back to Tacoma, and that the City, along with many partners, provided support to the company's grant application. She concluded by reminding everyone that tonight is National Night Out and it is also Primary Election Day.
