REPORTS BY THE CITY MANAGER

City Manager Pauli reported that the Public Works Department has received a grant from the Washington State Department of Transportation for the South 25th Street traffic safety enhancement project through the Highway Safety Improvement Program, noting the project is eligible for 100 percent of the project cost, will provide a bicycle connection between the Scott Pierson Trail and the Prairie Line Trail and various improvements, and is expected to begin in 2023 and be completed in 2025. She concluded by stating that the Tacoma Police Department has partnered with Titus-Will to begin Project CATCON ID to influence the business practice of identifying catalytic converters to reduce and eliminate catalytic converter theft, noting each catalytic converter would be etched with an identifying number, high heat resistant paint will be applied to mark the engraving location and window decals noting that the vehicle is tagged and protected, and this service will be provided for free on Friday, November 18, 2022, between 8:00 a.m. and 3:00 p.m., on a first come, first served basis.
