COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Council Member Hines, Chair of the Government Performance and Finance Committee, reported at the September 20, 2022, meeting, the Committee received presentations on Tacoma Public Utilities' preliminary budget and rates, the Accessory Dwelling Unit (ADU) Accelerator Program, and the Recycle Reset project; on October 4, 2022, the Committee received presentations on proposed updates to the Tacoma Municipal Code regarding for-hire regulations, and the ADU Accelerator Program; and at today's meeting, the Committee received presentations on Washington State Senate Bill 5755 regarding sales and use tax incentive program to encourage redevelopment of vacant lands in urban areas, and a review of the Multi-Family Property Tax Exemption Program. He concluded by stating the next meeting will be held in a hybrid format on November 1, 2022, at 10:00 a.m., and will include interviews for the Board of Ethics, an introduction to the Civil Service Board, and a presentation on the code of conduct for committees, boards, and commissions.

Infrastructure, Planning, and Sustainability Committee

Council Member Walker, Chair of the Infrastructure, Planning, and Sustainability Committee, reported at the September 28, 2022, meeting, the Committee received presentations on the Sustainable Tacoma Commission's annual report, the Climate Action Plan budget proposal, and ADUs; and on October 12, 2022, the Committee received presentations on Home in Tacoma Project Phase 2 and the Transfer of Development Rights Program.

She concluded by stating the next meeting will be held in a hybrid format on October 26, 2022, at 4:30 p.m., and will include presentations on the Capital Facilities Program and the consideration of a moratorium for the South Tacoma Groundwater Protection District.
