City Manager Elizabeth Pauli addressed comments from Community Forum regarding homeless encampments, noting a tent shelter site at South 35th Street and Pacific Avenue will be opening on Monday, November 14, 2022; it is designed as a bring your own tent site; notices were posted at the encampment adjacent to the site on Tuesday, November 1, 2022; and that there has been a large increase in the number of individuals at the adjacent encampment. She concluded by reminding the Council Members that there are 40 available beds at Catholic Community Services and 50 more will be available at the Tacoma Rescue Mission.
