Briefing Item

1. <u>22-0524</u> Historic Preservation Program and Landmarks Preservation Commission Annual Update

At approximately 12:01 p.m., Reuben McKnight, Historic Preservation Officer, Planning and Development Services (PDS), presented the Historic Preservation Program and Landmarks Preservation Commission annual update, including an overview; background; and Historic Preservation Program objectives, strategies, and programming achievements in 2022.

Council Member Daniels arrived here, at 12:05 p.m.

McKnight continued with review of Historic Preservation Program programming achievements in 2022; and the Landmarks Preservation Commission year in review, noting major projects reviewed.

Susan Johnson, Historic Preservation Coordinator, PDS, reviewed Historic Preservation Month for 2022, noting the theme of "Many Voices, Many Stories"; and upcoming events, noting information available online at hpmonthtacoma.com and cityoftacoma.org/historicpreservation.

McKnight concluded with review of 2022 program initiatives, including

historic surveys, the grant-funded underrepresented communities study, and increased partnership with the Puyallup Tribe of Indians.

Council Member Blocker arrived here, at 12:10 p.m.

Discussion ensued regarding the Tacoma History Museum's South Sound Japanese American Day of Remembrance on Tuesday, May 17, 2022; outreach; the role of the Tacoma Public Library and Northwest Room; making historic preservation part of growth and development rather than an obstacle; recognition of historic places and locations when the buildings are already lost; grant funding; projects; how people can get involved and learn more; and restoring history that was previously erased.

Other Items of Interest

Mayor Woodards stated that she plans to bring forward a statement on tonight's meeting agenda to express the City Council's support for upholding Roe v. Wade, in response to an expected United States Supreme Court decision.
