The City Council convened to Executive Session at 12:05 p.m. City Attorney Bill Fosbre and Steve Victor, Deputy City Attorney, City Attorney's Office, were present.

The Executive Session concluded, and the study session reconvened, at 12:36 p.m.

Mayor Woodards stated that during tonight's business meeting, the City Council will finalize the process to fill the At-Large Position 7 vacancy, including background, the Rules of Procedure of the Council of the City of Tacoma (Council Rules) related to final candidate selection, and opportunities for Council Members to make comments on individual candidates.

Discussion ensued regarding Council Rules, noting confirmation that Council Members can vote for more than one candidate, tie votes, and majority requirements; the process if no candidate receives a majority vote; and the high quality of finalists.

Briefing Items

1. 22-0865 Tideflats Subarea Plan Alternatives

At approximately 12:44 p.m., Deputy Mayor Ushka provided opening remarks and introduced Stephen Atkinson, Principal Planner, Planning and Development Services. Atkinson presented the Tideflats Subarea Plan alternatives, including an agenda and purpose; background; next steps in the City Council process; the planning process and milestones; the Environmental Impact Statement alternatives process; the scoping notification and engagement activities; types of comments received, noting the topics, sources, and number of contents; and further review of next steps.

Discussion ensued regarding the process to compile comments and provide them to Council Members, comments that address the final plan and not the scoping process, transportation studies, and the role of the Tideflats Advisory Group.

Victor then presented a proposed amendment to Ordinance No. 28786, regarding the Tideflats Non-Interim Regulations passed in 2021, including required review by the Washington State Department of Ecology (DOE); DOE's mandatory and recommended revisions; the purpose to clarify language related to conditional use permits (CUPs) in the Shoreline Master Program (SMP); and the process to bring forward an ordinance, noting that although an additional public hearing is not required, public comment will be taken.

Discussion ensued regarding previous conversations and public comment about CUPs, and providing assurance to the community that the DOE revisions align with existing City policy and do not substantively change the SMP.

Other Items of Interest

There were no other items of interest.
