22-0043 Camping Ordinance Update
 [Linda Stewart, Director, Neighborhood and Community Services]

At approximately 4:38 p.m., Linda Stewart, Director, Neighborhood and Community Services, presented an update on consideration of a proposed camping ban ordinance, including an overview of presentations at prior Community Vitality and Safety (CVS) Committee meetings; a timeline for updates based on Chair Ushka's December 14, 2021, letter to the full City Council, noting how other jurisdictions are handling this issue, implementing the divertible calls program, reliability of existing real-time shelter data, tracking of individuals who repeatedly refuse shelter, community volunteer options, meetings with stakeholders, public input, the draft Geographic Information Systems (GIS) map of schools, parks, and authorized camping areas related to a potential geography-based camping ban, and geography-based camping bans in other jurisdictions; and an explanation of the draft GIS map, including the map legend.

Discussion ensued regarding the purpose and complexity of the draft GIS map, appreciation for the work of City staff, whether to continue down the path of a geography-based camping ban, the levels of service available at each shelter site, shelter capacity at locations in each district, and unsanctioned camps.

6. 22-0044 Committees, Boards, and Commissions of CVS

[Ted Richardson, Senior Management Fellow, City Manager's Office]

At approximately 5:00 p.m., Ted Richardson, Senior Management Fellow, City Manager's Office, presented on the committees, boards, and commissions (CBCs) that CVS oversees, including an overview of a CBC discussion held at the September 23, 2021, CVS Committee meeting; and the purpose of each CBC, noting the Commission on Immigrant and Refugee Affairs, the Community's Police Advisory Committee, the Human Rights Commission, the Human Services Commission, the Tacoma Area Commission on Disabilities, and the Tacoma Community Redevelopment Authority.

Discussion ensued regarding communication with the CBCs, whether Council Members are interested in attending CBC meetings, the frequency of Council Member attendance at CBC meetings, how assignments would be made, and the format of CBC reports appearing at CVS Committee meetings.
