Briefing Items

At approximately 4:32 p.m., Doris Sorum, City Clerk, informed the Committee that they would be interviewing two applicants for the Human Services Commission who were unable to attend the May 12, 2022, interviews; that there is one member position available; and that there is one youth position that will remain vacant as no applicants qualified and the recruitment is ongoing.

The Committee interviewed Nikki Singh and Joseph Bradley.

Discussion ensued regarding candidate qualifications, the creation of a shortlist, and requirements for serving on committees, boards, and commissions and Commissioners.

Pierce County Comprehensive Plan to End Homelessness
[Heather Moss, Director, Pierce County Human Services;
John Barbee, Community Services Division Manager]

At approximately 5:00 p.m., Heather Moss, Director of Human Services, Pierce County, introduced John Barbee, Community Services Division Manager, Pierce County. Together they presented the Pierce County Comprehensive Plan to End Homelessness, including the process, community success, where people are when they become homeless, six goals of the plan, the functional zero concept to meet the needs of all homeless people, a comparison of current services and recommendations to meet the functional zero target, annual costs, recurring funding needs, rough estimates of capital funding, cost offsets, proposed initial funding, and next steps.

Discussion ensued regarding collective action between the City and Pierce County, the numbers of homeless individuals, how services should be distributed, how the City Council and Neighborhood and Community Services (NCS) staff can help with the work, services available outside the Tacoma city limits, this being a regional issue, the City shouldering the weight of this problem, work being done in neighboring cities, health care providers being on-site, ways to get neighboring cities to help or be held accountable, impacts of the City Council taking action to support the County's plan, funding, how Tacoma can get financial support from the County for data collection and other functional zero recommendations with available resources, and the work that NCS is doing with Pierce County Human Services.
