#### **Briefing Items**

3. <u>22-1078</u> Amendments to Tacoma Municipal Code 6B.220 - For-Hire Regulations
[Danielle Larson, Senior Financial Manager, Tax & License, Finance Department]

At approximately 10:04 a.m., Danielle Larson, Tax and License Manager, Finance, presented the proposed amendments to Tacoma Municipal Code Chapter 6B.220, relating to For-Hire Regulations, including an overview; background; issues; the health, equity, and sustainability analysis; outreach; and next steps.

Discussion ensued regarding the proposed amendments, Washington State regulations versus City code, taxi regulations versus transportation network companies regulations, equity and alignment, the sources and amount of fees, distribution of funds, and collecting fees.

MOTION: Council Member Bushnell moved to forward the proposed amendments to Tacoma Municipal Code Chapter 6B.220, relating to For-Hire Regulations to the full City Council for consideration.

4. 22-1079 Accessory Dwelling Unit Accelerator
[Stephen Antupit, Senior Planner, Planning and Development Services]

At approximately 10:16 a.m., Stephen Antupit, Senior Planner, Planning and Development Services (PDS), presented an update on encouraging and incentivizing the creation of Accessory Dwelling Units (ADUs), including an agenda; a review of ADU work at the Government Performance and Finance (GPF) Committee, noting meetings and topics to date; GPF Committee options, noting discussion and sequencing; the proposed first step, noting adding capacity and Detached ADU resources at PDS; and discussion and possible recommendation.

Chair Hines arrived here, at 10:22 a.m.

Discussion ensued regarding ADUs in historic districts, the end goals of the

plan, staffing and resource requirements for implementation, affordable housing, timelines, reimbursements for permit fees, pre-approved plans, and income requirements.
