Call To Order

Chair Walker called the meeting to order at 4:33 p.m.

Roll Call

Present: 4 - Hines, McCarthy, Ushka and Walker

All Council Members participated virtually.

Briefing Items

1. <u>22-0531</u> Planning Commission Interviews [Doris Sorum, City Clerk]

At approximately 4:33 p.m., Doris Sorum, City Clerk, informed the Committee that they would be interviewing five applicants for the Planning Commission, including Alyssa Torrez, who is seeking reappointment and has served since July 2019. She concluded by stating that there are three positions available, including the Architecture, Historic Preservation and/or Urban Design position, Environmental Community position, and District No. 4 position.

The Committee interviewed Alyssa Torrez, Laura Castrilli, Brett Marlo, Matthew Martenson, and Gabriel Clark.

The Infrastructure, Planning, and Sustainability Committee (IPS) meeting recessed at 5:25 p.m.

The IPS Committee meeting reconvened at 5:31 p.m.

Discussion ensued regarding the positions available, position requirements, and candidate qualifications.

MOTION: Vice Chair Hines moved to recommend the reappointment of Alyssa Torrez to the "District No. 4" position on the Planning Commission to serve a three-year term, effective July 1, 2022, to expire June 30, 2025.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

MOTION: Vice Chair Hines moved to recommend the appointment of Brett Marlo to the "Environmental Community" position on the Planning Commission to serve a three-year term, effective July 1, 2022, to expire June 30, 2025.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

22-0532 Vision Zero and Speed Reduction
 [Carrie Wilhelme, Senior Transportation Planner, Public Works]

At approximately 5:48 p.m., Carrie Wilhelme, Senior Transportation Planner, Public Works (PW), presented an update on the City's Vision Zero and speed reduction plan, including an overview; a history of Vision Zero and safe speeds, noting Resolution Nos. 40559 and 40600; the Vision Zero approach, noting comparisons to the traditional approach and safe systems; safe speeds, noting speed limit reduction targets and impacts; and the proposal to change speed limits on residential streets to 20 miles per hour, noting speed limits in other jurisdictions. Kris Norberg, Professional Engineer, PW, presented the proposal to reduce speed limits in Neighborhood Business Districts (NBDs) to 25 miles per hour, including findings from the NBD study, noting areas supporting speed reduction, pending coordination or projects, and areas where countermeasures would be needed. Wilhelme concluded by presenting projects underway and next steps.

Discussion ensued regarding speed enforcement, Tacoma Police Department resources, traffic calming practices, classification of residential versus arterial streets, parking areas along streets, quick-build projects, automatic cameras, equity in enforcement, determining the need for speed reduction, funding sources and uses, and the timeline for projects.

3. 22-0533 Urban Design Project Phase 1

This Item was continued to a date to be determined earlier in the meeting.

4. <u>22-0534</u> Sidewalk Funding [Chair Walker]

At approximately 6:28 p.m., Chair Walker presented an update on sidewalk funding in the City of Tacoma, including an overview of a presentation provided at the March 22, 2022, City Council study session; and how

communities are addressing missing and unsafe sidewalks, noting point of sale sidewalk repair, transportation impact fees, and streets initiatives.

Discussion ensued regarding work being done by the Government Performance and Finance Committee, sidewalk and curb requirements, the Local Improvement District process, the Tacoma Permit Advisory Group, utilizing the Equity Index in the City's Streets Initiative, funding to help property owners address unfit and unsafe sidewalks, the Bicycle Pedestrian Technical Advisory Group proposals, and the possibility of utilizing Build Back Better Act funds.

Discussion ensued regarding time expectations of meetings, time commitments, and possibly having different start times for meetings.
