SUBJECT: Waiver of Competitive Bidding Request-Sole Source
AGREEMENT WITH NORTHROP GRUMMAN INFORMATION TECHNOLOGY FOR EXPERT
COMPUTER SERVICES TO MIGRATE AND UPGRADE THE FIRE DEPARTMENT COMPUTER
AIDED DISPATCH SYSTEM TO NEW COMPUTER HARDWARE

Budgeted equally from the Fire Special Revenue Fund 1090 and the EMS Special
Revenue Fund 1155.

RECOMMENDATION: The Tacoma Fire Department requests a waiver of competitive procurement procedures and recommends that a contract in the amount of \$332,241 plus tax be awarded to Northrop Grumman Information Technology, Inc., Chantilly, Virginia, for expert professional computer services to migrate and upgrade the Fire Department's Computer Aided Dispatch System (CADS) to two new Hewlett Packard (HP) Integrity Series Application Servers.

EXPLANATION: The proposed increase funds additional programming for enhancements to CADS. The CADS is a proprietary custom computer application. Northrop Grumman has licensed the use of the software to the City of Tacoma. Northrop Grumman is the sole source manufacturer and software maintenance provider.

COMPETITIVE BIDDING: Waiver of competitive bidding requested due to sole source. The CADS is a proprietary software application. The Fire Department uses the software under license from Northrop Grumman. To ensure that the CADS hardware migration is successful and that any modifications and upgrades performed to the application work correctly and appropriately with the existing software code and to ensure that any work done will work with any future product upgrades or improvements, the purchase must be made from and the work, must be performed by Northrop Grumman.

CONTRACT HISTORY. In 1988, the City of Tacoma competitively solicited for a CADS system for the Fire Department Communications Center. PRC, which was eventually purchased by Northrop Grumman, was awarded a contract to implement CADS for the Fire Department. Over the past two decades, many upgrades and improvements to CADS Were made, including a recent \$630,000 real time mapping software upgrade completed in 2007, The proposed hardware migration represents the third generation of hardware for the application. Due to the proprietary nature of the software and the license agreement with the vendor, all maintenance, modification, hardware and software upgrade work has been contracted to Northrop Grumman.

FUNDING: Funds for the proposed purchase are available and will be expensed in equal amounts from the 2009-2010 Fire Special Revenue Fund 1090 budget, Cost Center 668500, Cost Element 531 01 00 and the Fire EMS Special Revenue Fund 11 55, Cost Center 6091 00, Cost Element 531 01 00.
