- 7. BACKGROUND INFORMATION/GENERAL DiscussiON: (Why is this request necessary? Are there legal requirements? What are the viable alternatives? Who has been involved in the process?) Per Council resolution 30525, the Landmarks Preservation Commission is tasked with the responsibility to review proposed naming and renaming of public facilities, upon request of the Mayor. The above name changes were forwarded to the Landmarks Preservation Commission on August 11, 2009. The Commission held a public hearing on September 23, 2009, to take public comment on this proposed name changes. Notice was published in the Tacoma News Tribune on September 13, 2009, and mailed on September 10, 2009, to property owners within 400' of the subject properties. In addition, notice was sent electronically to the Landmarks Preservation Commission distribution list. Following the public hearing, the Commission observed a 30 day comment period. During this comment period, an error in addressing for the "Harry P Cain Promenade" public notice was discovered; a correction notice was sent on October 20, 2009 via mail and electronic distribution. Following the comment period, the Commission voted to recommend adoption of the proposed name at its regular meeting of October 28, 2009.
