ITEMS OF INTEREST

1. **Environmental Services, Urban Forestry, Community Tree Program Update:** Funded in 2022 and launched in 2023, the Community Tree Program expands Tacoma's urban forest by reducing barriers to tree planting, education, and engagement in low-canopy neighborhoods, or "priority areas". The program is a partnership between the City of Tacoma and Tacoma Tree Foundation aligning municipal resources with community-based implementation. Staff has worked to provide intentional opportunities for Tacoma's multi-lingual communities to participate, reinforcing that belonging and inclusion are as essential to urban forestry programming as the trees themselves.

To date, 1,679 trees have been distributed to 667 households, 88% in priority areas, with 498 volunteers supporting these neighborhood plantings. We connected residents to tree resources at 39 outreach events and trained 115 community members in tree planting, pruning, and stewardship.

2. **City-funded Temporary and Emergency Shelter Performance:** The City posts weekly information about its Temporary and Emergency Shelter locations including current census, number of available beds, and exits to housing. **This information can be found at: <https://cms.tacoma.gov/ncs/weeklydataupdate.pdf> and is updated weekly.**

Pierce County Human Services also uses the Homeless Management Information System to report daily availability throughout Pierce County. 3. **Encampment Outreach:** For the week of December 22 - 26, 2025, the HEAL team visited 11 locations. This resulted in 15 (8 new, and 7 repeat) individuals contacted and referred to community services; 3 individuals accepted shelter placement.  - To help accelerate the delivery of "**middle housing**" developments, we're launching a one-year pilot program in January 2026 to streamline the permitting process. The program will help expedite residential projects with 7 to 20 units and townhome subdivisions consisting of 10 to 20 homes by staff and resources to reduce back-and-forth delays. This effort will help us meet our Home in Tacoma goal to provide more homes for more people by bridging the gap between single-family homes and large-scale development.






